

<u>Mike Bertsch</u> – Lake Sawyer Park Foundation, Meeting March 1st at Black Diamond Library at 7:00 PM and every other month thereafter. Mission: Keeping park in forefront of the public. Provide a natural park for public as a 501c 3. Facilitate volunteer clearing and cleaning up in the Lake Sawyer Regional Park. Raise funds for these activities, and to provide for the transport of a Port-a-Potty and six months rental of same. The other six months rental were provided by the Lake Sawyer Community Club who also is interested in this Park.

George McPherson – Expressed he would like to get rid of hard feelings. Referring to a letter to the editor written by Kristen Bryant. Maple Valley Reporter, January 29, 2016. He wanted to know, what actually subsidized Yarrow Bay? Somehow the city lost \$10 + million? What are the facts about water system and Yarrow Bay? Did they lobby? What did they get? The 98 acres in dispute with Covington Water District, is it possible to find out facts? Article implied gift to Yarrow Bay.Conflicting views from attorney. Do we follow the attorney? Have we lost confidence in lawyer? Is it possible for workshop to speak to concerns? Can a facilitator come in and help city work through problems? Council cannot direct staff.

<u>Pam McCain</u> – Stated she is a voting taxpayer and member of public. She voted for the strong mayor form of government. There is a systematic way of approaching change. Citizens distrust government, there is a huge level of distrust. Enough of the infighting. Worked within the rules and worked together.

<u>Pete Kelemen</u> – Thankful for the night meetings. New process allows public opinions & process discussed. Time span for public to get involved much greater now.

<u>Judy Carrier</u> – Appreciates the improved council's rules and our taking on the work to improve the committee rules. Evening times for committee meetings are making it easier for more of the public to participate in their governance. Minutes and audio recording put more information out in the community allowing citizens a more active roll. There is time for consideration. Expectations are that more substantive work will done by an active and informed public.

<u>Mira Hoke</u>- Gave a very impassioned view of her expectations for Black Diamond and its growth. The sediments were heartfelt but belong before our Comp. Plan review. I will find a proper venue for her input.

Chair Morgan asked Mr Derdowski to come forward and explain the changes exhibited in the "New Council Rules" as outlined in the redlined rendition which he distributed. She further explained that the changes were to correct blocks that were interfering with the public's right of self determination in their government as the local Sovereign Citizens, and that she had asked him to create a first draft of rules the Council could work with. The main principles that were the drivers were:

First, making sure committees do work in transparent way.

Second, use this structure to create thoroughness and rigor.

Third, to make Council accountable to the people, for their work.

The process for our discussion was that citizens could ask the questions they wanted us to research, and the results would be reported as they became available.

Robin Taylor - requested a citation for the power of Council to conduct its own business. She referred to RCW 35A.1.020 as it describes the Powers Vested in legislative bodies. She questioned the advantage of a process used by metropolitan jurisdictions when City of Black Diamond is small. Would like to know the RCW that gives Mayor Pro Temp extra power.

Bob Edelman – 7.2.11 Rule – Roberts Rules of Order to protect rights of minority. Why changed to a simple majority? Why was there a change from 4/5 that was needed? Can't tell if mayor can introduce rule change. What authorizes council to direct staff? Is city attorney part of staff? It was agreed his questions would be responded to in writing. He also asked for citations



Mayor Benson,

Thank you for contacting me about the mistake I was about to make with our Government Operations Council Committee, I will be amending the item:

b) Interview of Civil Service Commission Candidate Becky Arnold.

I changed the agenda item b) to instead read "Discuss the Role of the Civil Service Commission in the city generally". It would have been more help, if you had provided the citations you had in mind when you wrote As it is, I can only speculate upon what was in your mind, however your warning encouraged me to look more deeply into our Civil Service Commission parameters. What I think I found so far pertaining to the Civil Service Commission, is that if the Council has by ordinance, adopted qualifications required for this position, then the Council can not interview or interfere with the Mayors prerogative, regarding who is appointed to that position, so long as there is proof that the parameters stated in that ordinance have been met by the particular candidate.

As I understand the parameters for holding this position in Black Diamond, they are only the parameters directly from the State Code governing Civil Service Commissions. There has never been any local requirements added so that Black Diamond's Civil Service Rules and Procedures could be be relevant locally and particularly in Black Diamond, so what is currently required is:

Proof of United States Citizenship.

- 2. Proof of an active voter registration in King County.
- 3. Proof of three years residency inside the city limits.

I have been studying both our "Black Diamond Rules and Procedures of the Civil Service Commission" and Steven DeJulio's 90 page writeup from the MRSC website where he explains the whole state mandate for I have actually been to civil service commissions. about two Civil Service Commission Meetings in the past, they are public meetings subject to the OPMA. This is how I was well aware of how difficult it is to keep the positions filled. I think our Council Committee would be able to serve the public best with a presentation by Luzville Goebel, the city government Commission representative on the commission, and Chief Kiblinger to explain how the services of this Commission fit into the fabric that is Black Diamond.

Past holders of this Commission have over the years independently expressed to me a dismaying lack of scrutiny of their character, considering the Commission's stated purpose of assuring that there is a particular State Mandated system for hiring of full time Police, that excludes cronyism and patriotism. The "appointive term" for the holders of this commission post is six years, and these Commissioner's and barred from receiving any monetary compensation but their expenses can be paid within the IRS rules; all this to keep these Commissioners from being political appointees. After beginning a study of the rules as cited above I am not at all certain that the ambiguity which they detected about their character is not intentional in the law but in any case I would really like to have permission to discuss this aspect as well as other aspects of the Civil Service charge personally with Luzville and the Chief for my own better understanding of the function in our city. You can rest assured I will also be investigating other resources so that any product we come to has sound thinking behind it.

Currently Black Diamond with its 1546 households, is the quintessential place "where everybody knows your name" and likely your children, and your parents and

grandparents as well. I am particularly concerned because as Black Diamond grows to include 20,000 new citizens who all come into Black Diamond, citizens who do not share our particular culture of "having each others back" or our tight knit community values; there will inevitably be increased difficulty between both; citizens, and citizens and police, as there is in every larger community. I think we must do what we can to mitigate these issues. We all see bad results, daily blaring from the media, about bigger more mainstream America, Black Diamond's citizens understandably want protection from, what is happening across America. By taking a close look at Black Diamond's Civil Service Commission and how it is chosen, and what the requirements are for its Commissioners; before there is any influx of population will be an important step for staving off what may be inevitable and we must take every option available to us.

From Becky's application I personally think that most probably she might be a good candidate, remember I do know many of our citizens and many who know many others; but I would like to study the Civil Service Commission and its operation more thoroughly to be certain that the choice I make is the right one for BD for the next 6 years.
