Black Diamond PD - 2014 Marine Services Recap

While our busiest time of the year on Lake Sawyer is during the summer (peak-season), we continue to maintain marine-ready enforcement/emergency response during all months (off-season). Typically you will see our main patrol vessel deployed during the months of May-October which gives us safer enforcement capability. Our secondary vessel is deployed all year, with an emphasis on off-season enforcement/emergency response. The police department and fire department both have the capability to use the secondary vessel to ensure a fast response on Lake Sawyer, if needed.



This year we began 2014 by replacing/moving some navigation buoys on the lake. We will again do this at the beginning of 2015 as part of our yearly safety review of the lake before the peak-season begins.

In May, Sergeant Martinez and Officer Ross completed the Basic Marine Law

City Budgets for 2015

Earlier this summer, the City began budget development under the guidance of Mayor Dave Gordon. The 2015 budget includes operating costs for Public Safety and General Government revenue and expenditures. It also includes budgets for the Street Fund, Water Fund, Wastewater Fund and Stormwater Fund. The 2015 capital projects are also included in the document.

With notice of the Funding Agreement limited wind-down, Council deliberations on the 2015 City Budget expanded to

four workstudies in October; two public hearings related to the operating budget are scheduled for November, one on proposed revenues and expenditures for 2015 and the other on the 2015 property tax levy.

On December 1, Council will conduct a final public hearing on the 2015 City Budget and will consider budget adoption at the December 18 Council meeting.

A copy of the 2015 Preliminary Budget will be available on November 14 to view

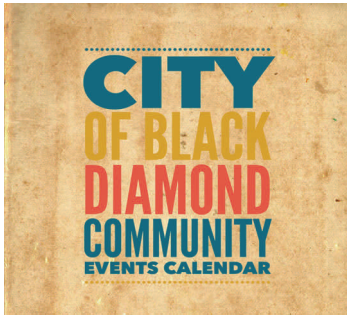

PROPOSED MEETING DATES - 2015 BUDGET

- ★ November 6 - Council holds public hearing on property tax levy for 2015 budget.
- ★ November 20 - Council holds public hearing on revenue sources and expenditures for upcoming budget year. Copies of the Preliminary Budget made available to the public on November 14. Council adopts property tax levy for the 2015 budget.
- ★ December 1 - Council holds final public hearing on 2015 budget.
- ★ December 18 - Council adopts final 2015 budget and transmits to the State Auditor's Office.

Business License renewals are coming soon....

The City of Black Diamond has approximately 395 businesses that operate in the City throughout the calendar year. These include retail stores, restaurants, real estate agents, hair salons, daycares, construction firms and more. Some of these businesses have storefronts here in Black Diamond, others are home occupations, and still more perform frequent business in Black Diamond but have offices elsewhere.

The Black Diamond Municipal Code 2.58 requires businesses operating in the City of Black Diamond have a current license. The license helps ensure all businesses have acquired the appropriate state licenses and permits, adhere to the zoning guidelines, conform to all building codes, and meet safety requirements. Most businesses are characterized as regular licenses, but the City also has some specialty licenses for pawnbrokers, carnivals, adult entertainment, firearms, solicitors/mobile vendors and utility licenses. Some businesses may require more than one type of license.

Solicitors are required to obtain their license before contacting the public. Background checks are performed on every solicitor operating in Black Diamond. If they are not able to produce a copy of the solicitor license upon request, they are not approved to solicit within City limits.

Business license permitting fees are based on the type of business, location and period of operation. **The majority of Black Diamond businesses are classified as regular, which are \$70 new and renew at \$60 annually. Renewal forms will be sent out in mid-December.** Renewals not postmarked by January 31st, 2015 will be assessed a \$10 late fee. Late fees will continue to assess monthly if licenses fees are not paid. Anyone not renewed by May 1, 2015 will be sent to a collection agency for unpaid fees. **If your business has closed or no longer is working in Black Diamond please return the renewal form with that information written on the form.** The City will cancel the license.

If you have any questions, please contact the City at 360-886-5700. We would like this process to be as simple as possible. Please remember to sign and return the renewal form and enclose the payment. Checks should be made payable to the City of Black Diamond. If you are a new business, applications are available on the City website or at City Hall. Generally a **new** license will have a fee of \$70, unless it is a specialty license or a temporary.

Winterizing your Water Pipes

To prevent the mess and aggravation of frozen water pipes, protect your home, apartment or business by following these simple steps:

Locate and insulate pipes most susceptible to freezing, typically those near outer walls, in crawl spaces or in the attic; wrap pipes with heat tape (UL approved); seal any leaks that allow cold air inside where pipes are located; disconnect garden hoses and shut off and drain water from pipes leading to outside faucets. This reduces the chance of freezing in the short span of pipe just inside the house.

When it's cold, let hot and cold water trickle at night from a faucet on an outside wall; open cabinet doors to allow more heat to get to un-insulated pipes under a sink or appliance near an outer wall; make sure heat is left on and set no lower than 55 degrees; if you plan to be away:

(1) Have someone check your house daily to make sure the heat is still

Enforcement class in Kennewick, WA. This 44-hour class gives the officer the training needed to safely enforce boating laws on any body of water. In October, Officer Tapecc attended the Marine Conference which the state requires us to attend. This conference provides training on marine-related items which will be presented to the rest of the department, as well as many administrative updates to maintain a boating program as a law enforcement agency.



The Marine Service Unit's primary duty is to enforce and educate boaters about the boating laws on beautiful Lake Sawyer. In addition, we perform boating safety inspections, investigate boating accidents, attend community events on the lake (4th of July Festivities & Lake Sawyer Annual Meeting), and maintain our current patrol vessels to ensure they are in proper working order. 2014 was a safe year on Lake Sawyer as there were no reportable accidents or injuries. Overall, officers conducted over 165 hours of on-water time on the lake which led to 115 vessel inspections, 420 visual spot inspections, 30 warnings, and 15 boating-related citations (including 1 Boating under the Influence arrest).

We encourage you to visit the Black Diamond Police Department's website at www.ci.blackdiamond.wa.us and click on the Marine Services section for specific Lake Sawyer Boating Regulations or visit the Washington State Parks & Recreation website for state laws regarding boating. The phase in period for the Boater Education Card requirement is over as of 2015. All boat operators, except those exempted elsewhere in RCW 79A.60.640, must have a Boater Education Card before operating a motorized vessel of 15 horsepower or greater.

on to prevent freezing, or (2) drain and shut off the water system (except indoor sprinkler systems). If pipes freeze, make sure you and your family know how to shut off the water in case pipes burst. Stopping the water flow will minimize the damage to your home. Call a plumber and contact your insurance agent; never try to thaw a pipe with an open flame or torch; always be careful of the potential for electric shock in and around standing water.



WINTER EMERGENCY TIPS

While the danger from winter weather varies across the country, nearly everyone, regardless of where they live, are likely to face some type of severe winter weather at some point in their lives. Winter storms can range from a moderate snow over a few hours to a blizzard with blinding, wind-driven snow that lasts for several days. Many winter storms are accompanied by dangerously low temperatures and sometimes by strong winds, icing, sleet and freezing rain.



One of the primary concerns is the winter weather's ability to knock out heat, power and communications services to your home or office, sometimes for days at a time. Heavy snowfall and extreme cold can immobilize

an entire region. It is important to be prepared for winter weather before it strikes. To prepare for a winter storm you should make sure you have the following:

- * Rock salt or more environmentally safe products to melt ice on walkways. Visit the [Environmental Protection Agency](#) for a complete list of recommended products.
- * Sand to improve traction, snow shovels and other snow removal equipment.
- * Minimize travel. If travel is necessary, keep a disaster supplies kit in your vehicle.
- * Sufficient heating fuel. You may become isolated in your home and regular fuel sources may be cut off. Store a good supply of dry, seasoned wood for your fireplace or wood-burning stove.
- * Adequate clothing and blankets to keep you warm.

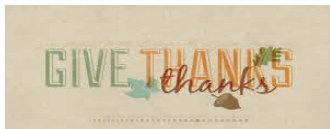
COMMUNITY DEVELOPMENT HOLIDAY HOURS

- * Make a [Family Communications Plan](#). Your family may not be together when disaster strikes, so it is important to know how you will contact one another, how you will get back together and what you will do in case of an emergency.
- * Get a NOAA Weather Radio which broadcasts alerts and warnings directly from the NWS for all hazards.
- * Free smart phone apps are available from FEMA and the American Red Cross which provide information about finding shelters, providing first aid, and seeking assistance for recovery.
