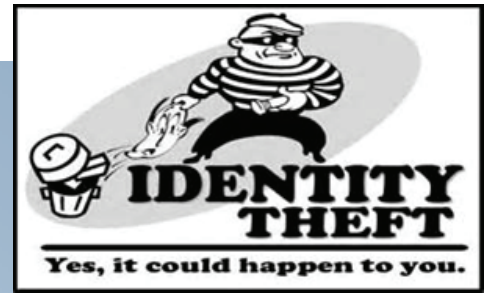

Police Department >>> *Preventing Theft of Mail...*



The theft of mail from residential mailboxes is an increasing problem. Con artists use this as a means to obtain your identity information and to steal checks and other items of value. This problem can be reduced or minimized by following these tips:

- Do not leave outgoing mail in your unlocked mailbox.
 - Deposit mail in a blue collection box or inside your local post office. Don't leave mail in a collection box that is full.
 - Promptly pick up your incoming mail after it is delivered.
 - Get together with neighbors and the Postal Service and arrange for the installation of locked group mailboxes for neighborhood delivery. These are known as Neighborhood Delivery & Collection Box Units (NDCBU). Each address has an individual locked unit for delivery and collection. A minimum of seven neighbors is needed to sign a petition requesting an NDCBU.
 - Purchase a locked mailbox or convert your unlocked box to the lockable type. Make sure the mail slot is large enough for the letter carrier to insert your mail. The letter carrier cannot pick up mail from this type of box.
 - Arrange for your mail to be delivered to a Post Office box for a small fee.
 - Have regular income checks deposited electronically into your bank account via direct deposit.
 - Promptly contact the senders if you do not receive credit cards, checks, or other valuable mail.
 - Notify the post office and mailers if you change your address. When going on vacation, have the post office hold your mail or have a trusted friend or neighbor pick up your mail after delivery.
 - Be observant of activities on your street, including those near your letter carrier, the postal vehicle, residential mailboxes, and collection boxes.
 - If you see suspicious persons or activity, call 911 while the suspects are still present.
- To "opt out" of receiving pre-approved credit and insurance offers from the credit bureau mailing lists call: 18885OPTOUT (1-888-567-8688) or visit: www.optoutprescreen.com.

By following these tips and using common sense, you can lessen your chances of being a victim of mail theft and possible identity theft. If you have questions about postal regulations, contact your local postmaster.

The **Community Emergency Response Team (CERT)** Program educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. Using the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help. CERT members also are encouraged to support emergency response agencies by taking a more active role in emergency preparedness projects in their community.

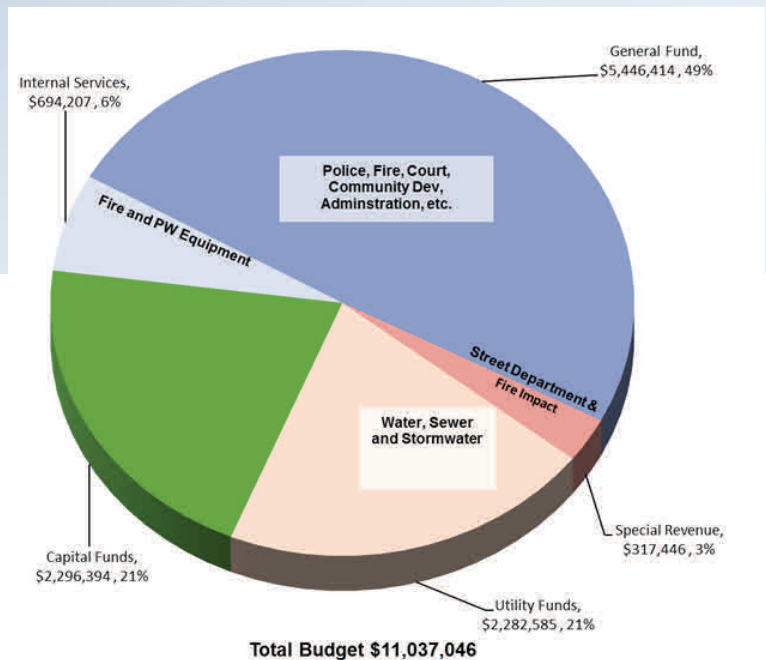
Finance Department >>> Council Adopts 2015 Budget...

On December 1, 2014, Council adopted Ordinance No. 14-1038 approving the budget for 2015. Council began deliberations on the budget at committee and workstudy meetings in October and held public hearings in November and a final public hearing December 1, 2014.

The total 2015 budget of \$11,037,046 decreased by \$1,207,642 or 9.9% from 2014. This was due to the Funding Agreement reductions and completion of several Capital Projects. All funds are in balance and they include funds for Public Safety, General Government as well as Street, Water, Sewer, Stormwater and Capital Project funds. New Capital projects for 2015 include funds for the General Comprehensive Plan and Water Plan updates, and painting the Water Reservoir as well as Technology and Equipment replacements.

The 2015 budget honors the adopted Financial Management Policy of the city that recommends the General Fund maintain at least 10% in ending Fund Balance. The budgeted 2015 ending balance of \$645,080 is \$79,627 higher than last year and \$233,947 above the 10% recommended policy. All funds are in balance and they include funds for Public Safety, General Government as well as Street, Water, Sewer, Stormwater and Capital Project funds. New Capital projects for 2015 include TIB Grants received for the Rock Creek Bridge Project, and the Lawson Street Sidewalk Project as well as a DOE Grant for a Stormwater Treatment pond.

The Ordinance #14-1038 adopting the 2014 Budget is available on the city website. A final updated 2014 Budget Document will be available by February 20, 2015.

Water Department >>> 2015 Utility Rate Increases...

Council has the responsibility to insure that each Utility Fund has sufficient rates to provide the funds for their Maintenance and Operation, Debt payments and Capital costs. The following monthly rates will increase effective January, with payments due in February, 2015:

The Sewer Metro rates are remitted monthly to Metro for their Sewer Treatment processing. Stormwater rates did not increase and will remain at \$16.00 per Equivalent Residential Unit (ERU). Discounted Lifeline rates for city share rates are available to low-income or disabled utility customers at 50% of the initial listed rates. Applications are available annually on the city website - www.ci.blackdiamond.wa.us.

Emergency Management - Know the winter terms ...

Know the terms used to describe changing winter weather conditions and what actions to take. These terms can be used to determine the timeline and severity of an approaching storm. (Advisory/Watch/Warning). The NWS also issues advisories and warnings for other winter weather, including blizzards, freezes, wind-chill, and dense fog. Be alert to weather reports and tune in for specific guidance when these conditions develop:



***Freezing Rain** - Rain that freezes when it hits the ground, creating a coating of ice on roads, walkways, trees and power lines.

***Sleet** - Rain that turns to ice pellets before reaching the ground. Sleet also causes moisture on roads to freeze and become slippery.

***Wind Chill**- Wind-chill is the temperature it “feels like” when you are outside. The NWS provides a Wind-chill Chart to show the difference between air temperature and the perceived temperature and the amount of time until frostbite occurs. ***Winter Weather Advisory** - Winter weather conditions are expected to cause significant inconveniences and may be hazardous. When caution is used, these situations should not be life threatening. The NWS issues a winter weather advisory when conditions are expected to cause significant inconveniences that may be hazardous. If caution is used, these situations should not be life-threatening.

***Winter Storm Watch** - A winter storm is possible in your area. Tune in to NOAA Weather Radio, commercial radio, or television for more information. The NWS issues a winter storm watch when severe winter conditions, such as heavy snow and/or ice, may affect your area but the location and timing are still uncertain. A winter storm watch is issued 12 to 36 hours in advance of a potential severe storm. Tune in to NOAA Weather Radio, local radio, TV, or other news sources for more information. Monitor alerts, check your emergency supplies, and gather any items you may need if you lose power.

***Winter Storm Warning** - A winter storm is occurring or will soon occur in your area.

***Blizzard Warning** - Sustained winds or frequent gusts to 35 miles per hour or greater and considerable amounts of falling or blowing snow (reducing visibility to less than a quarter mile) are expected to prevail for a period of three hours or longer.

***Frost/Freeze Warning** - Below freezing temperatures are expected.
