A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
BLACK DIAMOND, KING COUNTY, WASHINGTON  
AUTHORIZING THE MAYOR TO EXECUTE A PURCHASE  
AGREEMENT FOR TWO SIX FOOT PARK BENCHES  
FROM CASCADE RECREATION

**WHEREAS**, the City desires to place two six foot park benches at the Lake Sawyer regional park; and

**WHEREAS**, Cascade Recreation Inc. supplied the lowest bid in the amount of \$1,537.78 for two six foot park benches; and

**WHEREAS**, the City will work in partnership with the Lake Sawyer Park Foundation in the purchase of the park benches, with each party supplying 50 percent of the purchase price, which equates to a cost to the City of \$768.89 towards their purchase; and

**WHEREAS**, funding is available through the REET grant matching fund;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, WASHINGTON, DOES RESOLVE AS FOLLOWS:**


**Section 1.** The Mayor is hereby authorized to purchase from Cascade Recreation Inc. two park benches for the Lake Sawyer Regional Park.


