On February 11th, I received a phone call at the station reference this same incident and spoke with the anonymous caller. The caller advised the dog was barking in the middle of the night too. I asked the caller if they have contacted their neighbor and they declined to do that. I provided the caller with details to document to noise so a citation could be issued in the future. The caller agreed to do this and I advised I would continue to attempt to talk to the dog's owner.

On February 13th, I was able to make contact with the homeowner by telephone. The homeowner advised they would keep the dog in the house during the day and advised the dog is never outside at night. The homeowner stated she knew who was calling, advising it was [REDACTED], adding that [REDACTED] will not quit complaining. The homeowner advised she has spoken to all her other neighbors and they have no issue with the dog. I explained the noise ordinance to her and she advised she understood.
